### For the Students & Parents of Class X & XII (2019-20)

As you are aware that all the Board exams of class X & XII (2019-20) scheduled w.e.f. March 13, 2020 onwards conducted by CBSE at Centre Numbers 9044 and 9045 (international Indian School Jeddah) were suspended in compliance to the instructions received from the Ministry of Education (KSA) and the Embassy of India, Riyadh in the light of the critical situation due to the spread of coronavirus. Now, as per the notification dated March 18, 2020 issued by CBSE (copy enclosed), all the X & XII class Board examinations scheduled between 19<sup>th</sup> to 31<sup>st</sup> March (both dates inclusive) shall be rescheduled after March 31 2020.

The Embassy of India has taken up the case of all such suspended Board exams of class X & XII scheduled between March 13 to March 18, 2020 with CBSE and it is expected that the cancelled exams may be conducted by the Board after March 31 2020.

Students are advised to continue and keep pace with the preparation for the remaining exams. Any update in this regard will be communicated to all the concerned.

### NOTIFICATION

As a precautionary measure and in compliance of the instructions received from Secretary, Department of Higher Education/ School Education and Literacy, Government of India vide letter No. Secy (HE)/MHRD/2020 dated 18<sup>th</sup> March, 2020, it has been decided as follows:

1. All ongoing examinations of the board for classes-X and XII, being held in examination centres in India and abroad, and scheduled between 19.03.2020 to 31.03.2020 (both dates inclusive), shall be rescheduled after 31<sup>st</sup> March, 2020.
2. During the aforementioned period, re-examinations that were rescheduled to be held for North-East Delhi candidates will also be further rescheduled.
3. All schools may ensure that this information is disseminated to all concerned students from their respective schools.
4. Rescheduled dates will be communicated by the board to all its stakeholders by 31.03.2020 after re-assessment of the situation.
5. All ongoing board exams related evaluation work in various evaluation centres in the country is also suspended upto 31<sup>st</sup> March, 2020. All Centre Nodal Supervisors may ensure rescheduling of evaluation work from 01.04.2020, unless otherwise informed by the Board.


