### Subject: Invitation of Applications for School Scholarship Scheme (SSS) -2021-22 for the Students of Grade VI to XII at International Indian School Jeddah

*Dear Parents,*

In view of the ongoing COVID crisis which has impacted the financial condition of several parents, International Indian School Jeddah (IISJ) has decided to implement a School **Scholarship Scheme (SSS)** to benefit certain categories of students. You are advised to carefully read the following information before applying for availing the benefit under this scheme:

#### Terms & Conditions for Applicants:

- The scheme is applicable for Indian parents whose aggregate monthly salary is between SAR 2,500/- to SAR 3,000/- only.
- This is a scheme chiefly meant for extremely needy and financially disadvantaged parents.
- The needy parents who fulfil the eligibility criteria may apply on a prescribed application form attached with this circular.
- School Scholarship Scheme is applicable to Boys' and Girls' Sections separately.
- Students should have completed a minimum period of 2 years of study at IISJ to be eligible to be an applicant for this scheme.
- It will be considered once in an academic year unless reviewed by the administration.
- The benefit under this scheme is extended to only one child of the family.
- It is not a merit scholarship. The only consideration under this scheme is the financial and economic condition of the parents.
- The willing parents have to furnish the documents for their collective proof of income (husband and wife) duly attested by their employers and the General Organisation for Social Insurance (GOSI) certificate with the mention of their salary.

In case of the failure of parents for not having either of the above two certifications, their applications will not be considered.

The last date of submission of duly filled-in application in prescribed format is Monday, September 20, 2021. Application other than that in the prescribed format will not be accepted. Duly filled in application with relevant documents may kindly be submitted to the Boys' Section Fee Counter between 9.00 AM to 2.00 PM (Sunday to Thursday).
