Subject: Screening Test for ad-hoc Teachers

This is to inform that a Screening Test will be conducted for the regularization of the services of existing ad-hoc teachers on Saturday, September 14, 2019 from 10:00 am to 12:30 pm in the Boys' Section. It includes Written Test followed by interview. The teachers working on ad hoc basis against clear vacancies in different blocks and are fulfilling the eligibility criteria as per Unified Service Rules may appear for the said test.

The Written test will comprise of the following papers:

1	Subject & Pedagogy	40 marks
2	General English	15 marks
3	General Awareness & Aptitude	15 marks
Total:		70 marks

Kindly note that the language teachers need not attempt General English paper. The subject paper for them will be out of 55 marks.

PETs will have a separate format of Test of 55 marks to be physically and orally evaluated by subject expert. However, they have to appear for written test for General Awareness & Aptitude test of 15 marks.

Candidates who secure a minimum of 60% in the subject and 50% overall will be eligible for the interview.
