Subject: Re-notification for School Sponsorship (SSS)-2020

Dear Parents,

With reference to the Circular No. IISJ/PR/2020-21/28, dated August 09, 2020, wherein applications were invited for School Sponsorship Scheme (SSS) and based on the guidelines issued by the higher authorities, scholarships were approved to the eligible students. After the initial allotment of scholarships, the school has found that a few more scholarships may be given in classes VI to XII with the exception of IX Boys, XI Girls and XII Boys. Eligible parents who could not apply against the first notification in the month of August 2020 may apply now.

Terms & Conditions for Applicants:

- The scheme is applicable for Indian parents whose aggregate monthly salary is between SAR 2,500/- to SAR 3,000/- only.
- This is a scheme chiefly meant for extremely needy and financially disadvantaged parents.
- The needy parents who fulfil the eligibility criteria may apply on a prescribed application form attached with this circular.
- School Scholarship Scheme is applicable to Boys' and Girls' Sections separately.
- Students should have completed a minimum period of 2 years of study at IISJ to be eligible to be an applicant for this scheme.
- It will be considered once in an academic year unless reviewed by the administration.
- The benefit under this scheme is extended to only one child of the family.
- It is not a merit scholarship. The only consideration under this scheme is the financial and economic condition of the parents.
- The willing parents have to furnish the documents for their collective proof of income (husband and wife) duly attested by their employers and General Organisation for Social Insurance (GOSI) certificate with the mention of their salary.

In case of the failure of parents for not having either of the above two certifications, their applications will not be considered.

The last date of submission of duly filled-in application in the prescribed format is December 08, 2020 by 04.00 PM at the Reception Counter in Boys' Section. Applications other than that in the prescribed format will not be accepted.
