CIRCULAR

(REGULAR CANDIDATES CLASSES X AND XII)

Subject: Online submission of LOC in respect of Regular Candidates of Class X & XII for Compartment / Improvement Examination August- September, 2021-regarding

In continuation of the Policies for Tabulation for classes X and XII and circular dated August 02, 2021, Optional and Compartment Examinations for the candidates for classes X and XII, have been scheduled from 25th August, 2021.

1. The following categories of Class X and XII regular candidates of session 2020-21 will be eligible to appear in this examination:

- (A) **NOT SATISFIED WITH ASSESSMENT**
Candidates whose result has been declared **PASSED** based on the Tabulation Policy but they are not satisfied with the assessment.
- (B) **COMPARTMENT**
Students who are not able to meet the qualifying criteria in one/two subject(s) and placed in compartment category in classes XII and X respectively.
- (C) **NON-COMPUTABLE CASES**
Candidates whose result could not be prepared on the basis of Tabulation Policy in 2021 i.e. regular candidates of improvement category.
- (D) **6th SUBJECT CASES**
Candidates who have appeared as regular candidates in 06 subjects in 2021 and declared as PASS but could not clear any one subject from the five main subjects.

2. SUBJECTS FOR EXAMINATION

CBSE will conduct the examinations in 19 subjects for Class XII and 10 subjects for Class X only as given in Annexure-1.

3. QUALIFYING CRITERIA

- (a) In category (A) above, marks scored in later examination will be considered as final as mentioned at point 28 in the policy for tabulation of marks.
- (b) In rest of the categories i.e. (B), (C) and (D), eligibility criteria as per policy of the Board will be applicable. However, where ever possible, policy as approved by Hon'ble Supreme Court of India in 2020 will be made applicable. However this policy shall not be applicable for the candidates registered for the improvement of performance in one or more subjects and additional subjects.

4. Following information may be noted for needful compliance by the schools/candidates-

- (a) Schools shall have to submit LOC in respect of all candidates who were regular students of their school during session 2020-21 and wish to appear in the examinations due to any reason mentioned from (A) to (D) above.
- (b) The regular students of session 2020-21 can submit their candidature through their respective schools only. There is no provision for applying directly to the Board.



- (c) The facility for the school to submit list of such candidates through CBSE website will remain available as per schedule given in Annexure-2.
- (d) Fee will be applicable as per details given in Annexure-2.
- (e) Schools will be informed about the date of downloading of the admit cards in due course. In case of any discrepancy in the Admit card, schools should contact concerned Regional Offices of the Board.
- (f) In case of any difficulty/queries regarding online submission, IT Unit of concerned Regional Offices can be contacted.
- (g) CBSE will be holding examinations at the designated centres in country and abroad.
- (h) Centre will be fixed keeping in view the COVID protocols and students will also be required to follow the same strictly.
- (i) In each centre, a smaller number of candidates will be allotted to implement social distancing norms strictly.
- (j) Before approaching the schools for submitting the forms/LOC, candidates are requested to read and understand the following Annexures carefully:
