Sub: Instructions to students/parents regarding Class XII Registration Form for Board Examination-2021.

1. Student and one parent (Father or mother or guardian) to visit the School (girls in Girls' Section Auditorium and boys in Boys' Section Auditorium) on the specified date and time as informed by the Class Teacher.
2. In view of the pandemic, thermal screening at the entrance, wearing of masks, and maintaining Social distancing is mandatory.
3. Items required to be brought:
 - (i) 2 passport size photographs(in School uniform on white back ground)
 - (ii) Examination fee Receipt: SAR 630/- + VAT 15 %
 - (iii) Class XI Board Registration Card.
4. Take the printed Form from the Class Teacher, verify the details printed in it with your class XI Board Registration Card. Both the student and parent will sign the Form and submit it to the Class Teacher with Examination Fee Receipt.
5. Fee counters will remain open for accepting the Examination Fee during the specified time.
6. Please note that no correction in the names of student, mother and father is permitted as these are as per Class X Certificate issued by CBSE.
7. Corrections in other entries are permitted with proof.
8. There is no proof required in case of correction in Annual income in INR.
9. If Aadhar Card is there, then mention the Aadhar Number but it is not mandatory.
